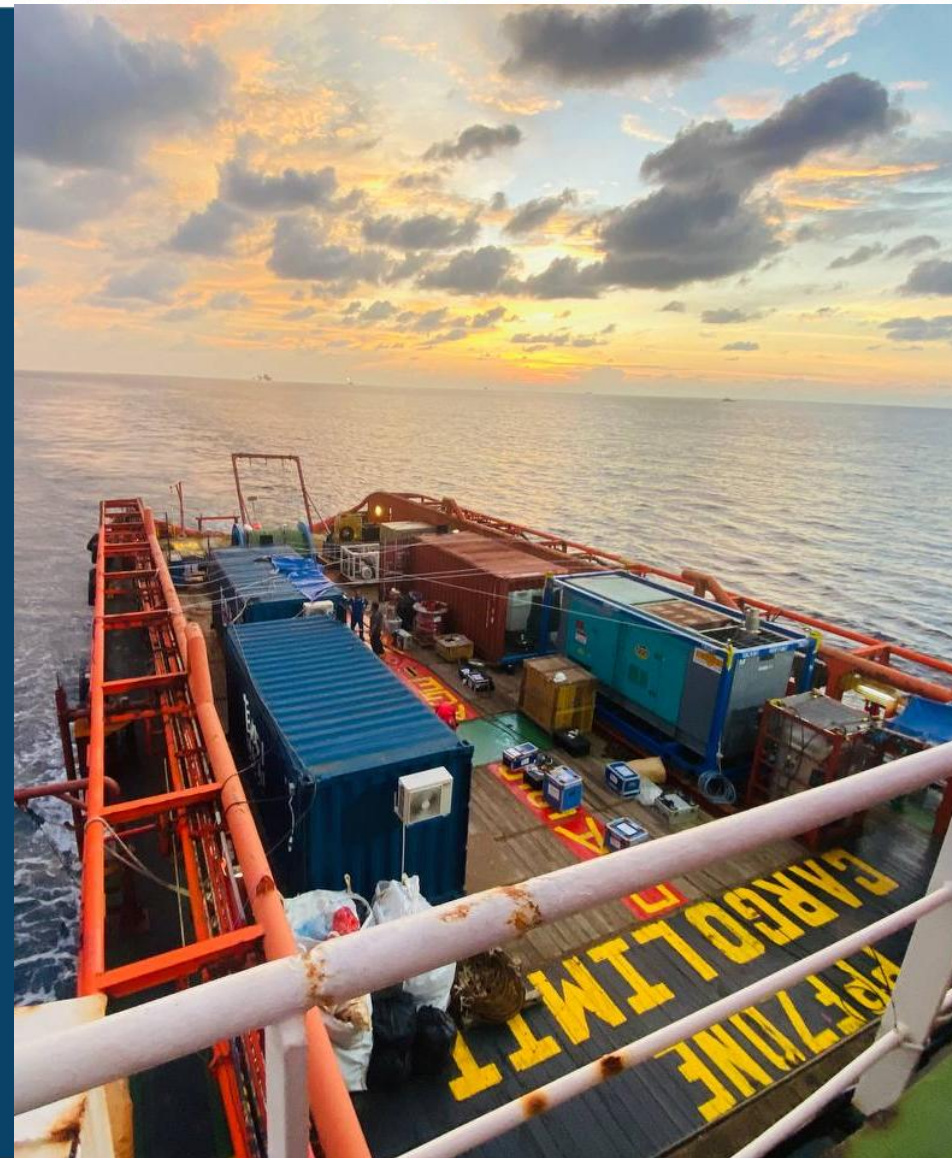

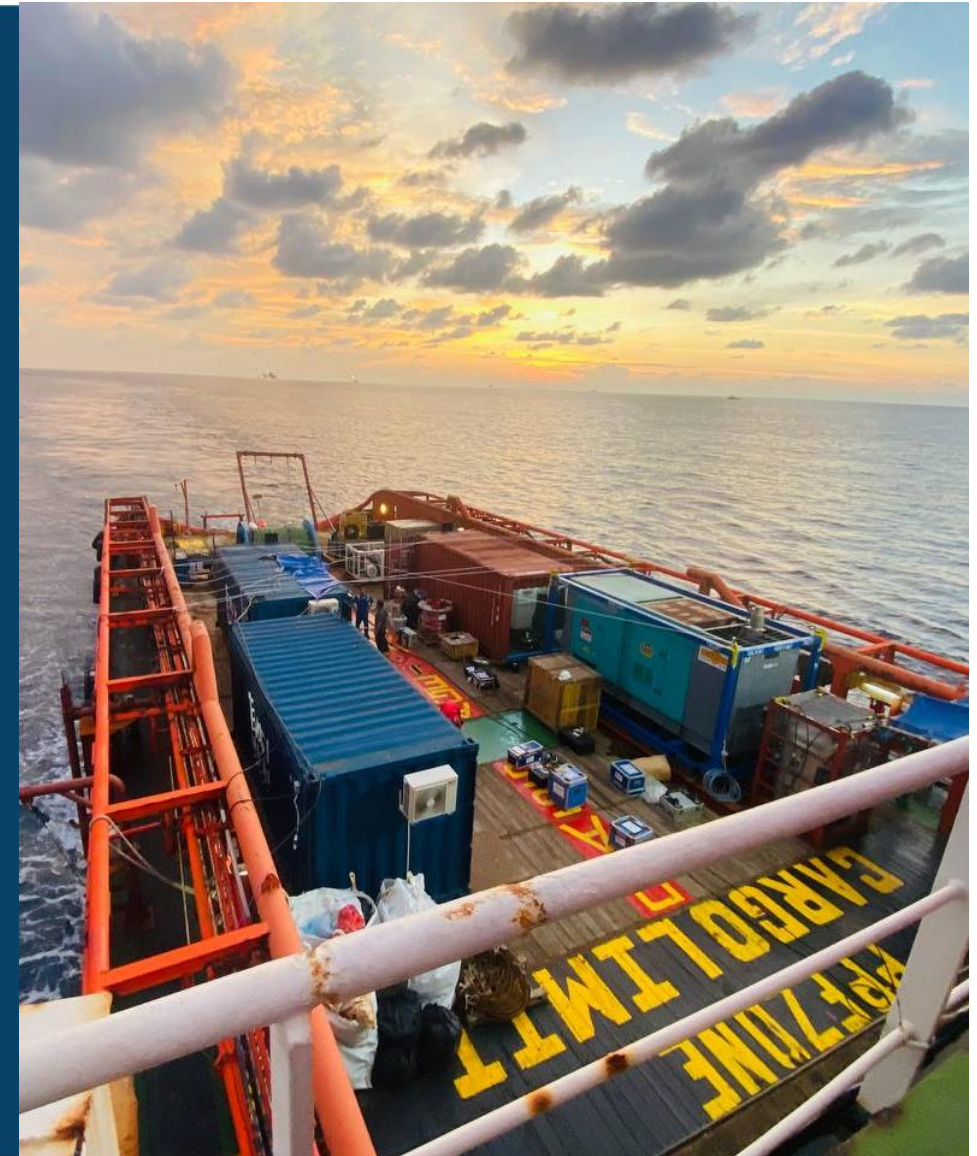
Marine Solutions



The provision of multiple activities related to vessels and rigs, are either provided to the clients within an integrated package or independently. Altus Oil & Gas's scope of work includes lay-up, preservation and maintenance, marine asset decommissioning, inspection and certification, and vessel charters.

Our lay-up services include hot lay-up mode (warm stacking) or cold lay-up (cold-staking). We evaluate the best lay-up location with the consideration of the client's asset current location and its next destination. To ensure the objective is met, we work with our clients to design the best turnkey lay-up scopes that match their cost-benefits, asset integrity and quick reactivation purposes.

Other than lay-up services, we are involved in equipment, spare parts and raw material preservation which covers the upstream and downstream industries. Preservation of equipment and spare parts is essential in maintaining the lifespan of the assets and managing the financial flow. At Altus Oil & Gas Malaysia, we provide state-of-the-art preservation services to our clients. The eco-friendly Vapour Corrosion Inhibitor (VCI) ensures spares are well preserved, at the same time minimising corrosion and damage while in storage. This preservation method covers a wide range of applications including electrical, mechanical and control systems.



Ship/Rig Lay-Ups

We recognise the critical importance of making informed decisions when laying up marine assets like vessels or rigs, especially during periods of low or no earnings. Our comprehensive approach is tailored to meet the specific requirements of our client's marine/rig assets while ensuring cost-effectiveness and asset integrity.

Our lay-up approach includes establishing hot or cold lay-up, selecting optimal lay-up locations and designing turnkey lay-up scopes that balance cost benefits, asset integrity, and rapid reactivation.

We provide comprehensive lay-up services from risk assessment, permit assistance, towing assistance, pilotage and towage, crew handling, boat services, security measures around the clock, towing and mooring analysis and design and installation, emergency response plan and procedures and asset maintenance.

Ship/Rig Preservations & Maintenance

Idle marine/rig assets face significant risks without proper preservation and maintenance strategies in place, including rapid corrosion and wood delamination/splitting due to high humidity, mechanical seizure of rotating and sliding equipment and other mechanical components, and deteriorating function of electric and electronic products.
